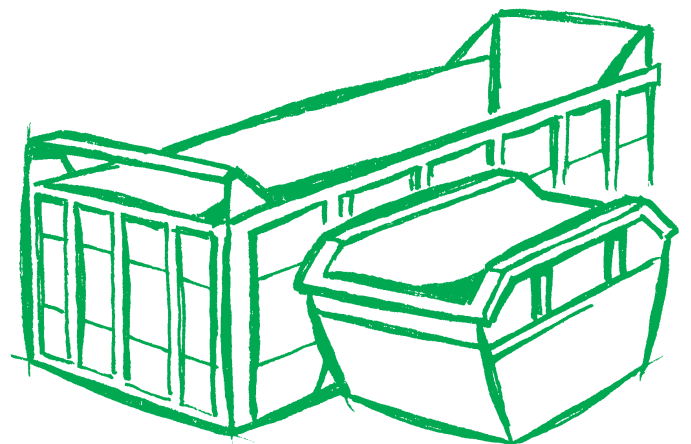

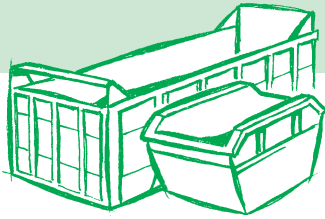
## **ABOUT US**

## DUTY OF CARE ADVICE

### DUTY OF CARE

**Every organisation that generates waste has a duty of care, the implications of which are numerous.**

**On site:** Preventing escape of waste requires thorough knowledge of all waste produced as well as proper planning for waste storage. On-site waste containers and their contents are solely the hirer's responsibility. To enable you to meet on-site requirements and legislation, we will provide enclosed skips for any special, hazardous or contaminated waste. We can also supply secure fencing for your skip compound.

**Off site:** The description of the waste must be adequate, to prevent it from being mishandled throughout the disposal chain.

Your duty of care doesn't end once you have handed over your waste to a suitable party. You must only select a carrier that is registered for your waste type. It is your responsibility to select a suitable transfer station and disposal site. You must check that the licence and facilities are appropriate for both the type and amount of waste you intend to send, ensuring it is handled correctly. You must also keep records of the movement of your waste and make them available for inspection for up to two years.

Broadoaks UK uses registered waste carriers to handle all your waste streams, ensuring your waste is disposed of at suitable recycling transfer stations and disposal sites.

However, you cannot contract out the duty of your care for your waste, and your company's management is always responsible for all acts and omissions by employees. When your waste is in someone else's hands your duty of care is shared, but as a producer of waste you will always have responsibility for its safe disposal.





# ENVIRONMENTAL POLICY

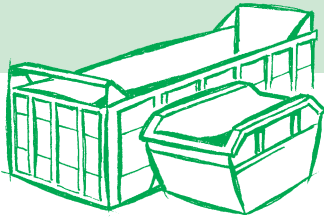
## WASTE

**The aims of our environmental policy are to:**

- Keep our customers' waste disposal costs to a minimum by ensuring waste is segregated and the maximum possible is recycled
- Reduce the percentage of waste sent to costly landfill sites and increase the percentage that is recycled and reused
- Ensure full compliance with legislation and to provide accurate information on any future policies
- Improve the understanding of the environmental aspects of waste handling, by educating waste producers and their agents
- Provide detailed continuity reports tracking the movement of waste - from production to collection to final destination
- Continually improve our green credentials and those of our customers, by striving to recycle approximately 95% of all waste collected from sites
- Work towards preserving and protecting the environment for future generations

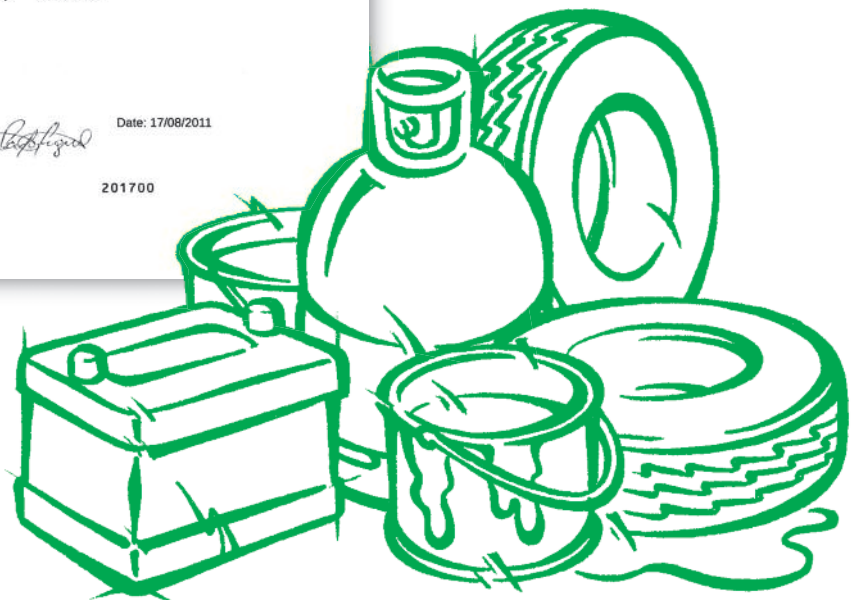

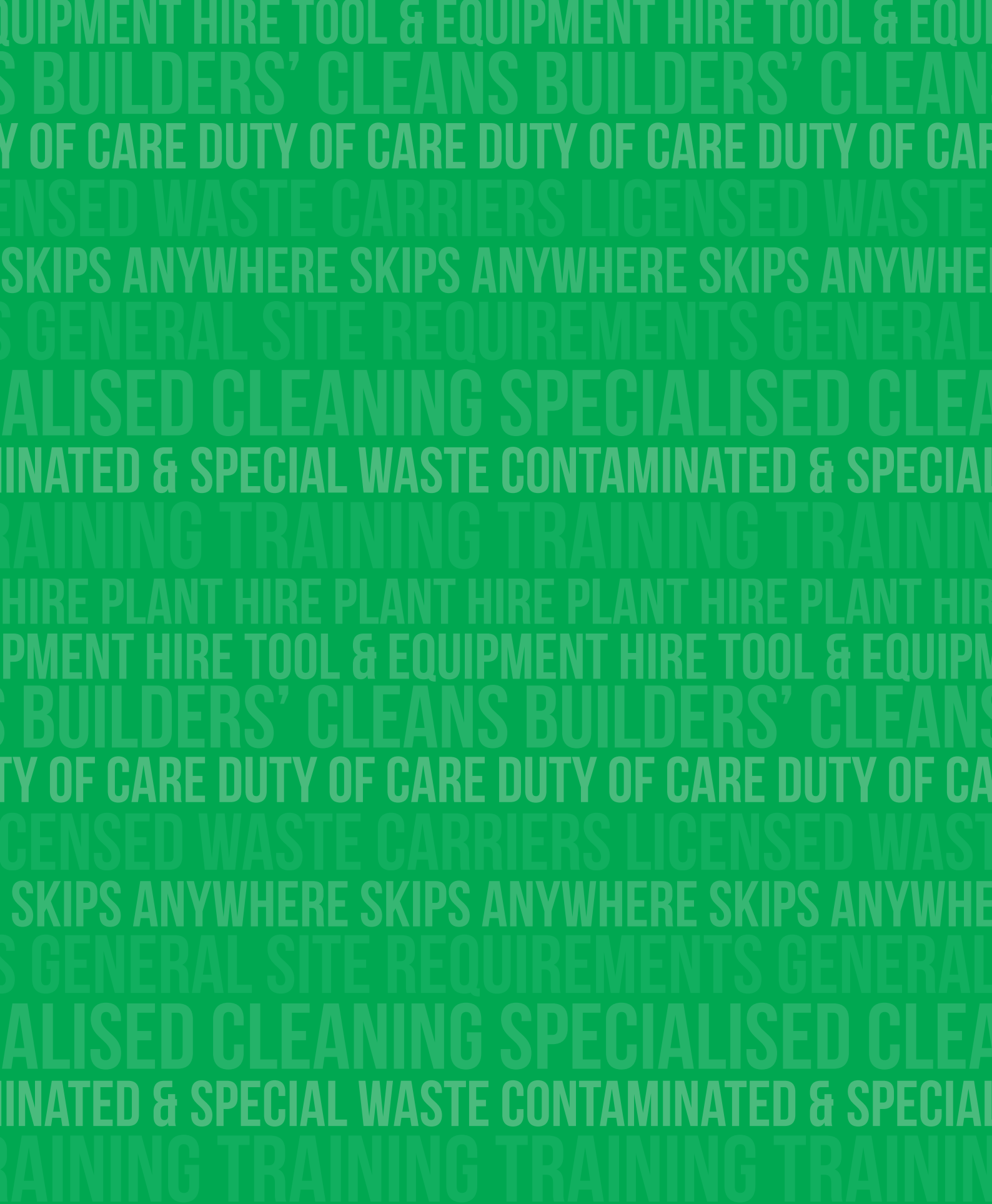
